

## 2025 PROSHOP 1987 SOCIAL SWEEPSTAKES

### OFFICIAL SWEEPSTAKES RULES

---

1. **Sponsor and Administrator:** 2025 ProShop 1987 Social Sweepstakes (“Sweepstakes”) is sponsored and administered by Boston Professional Hockey Association, Inc. (“Sponsor”).
2. **General:** By participating in this Sweepstakes the participant acknowledges and agrees to all of these Official Rules. Void where prohibited. Sweepstakes begins on Friday, December 12, 2025, at 10:00 AM, and runs until Monday, December 15, 2025, at 10:00 PM (collectively the “Sweepstakes Period”). The odds of winning a prize depend on total number of eligible entries received during the Sweepstakes Period (each an “Entry”). Sponsor cannot accurately predict the number of entrants who will participate in the Sweepstakes (each an “Entrant”). All times in this Sweepstakes refer to Eastern Time. By participating, Entrants agree to be bound by these Official Rules and by all decisions of the Sponsor, whose decisions are at its sole discretion and are binding and final. Failure to comply with these rules will result in disqualification from this Sweepstakes.
3. **Eligibility:** The Sweepstakes is open only to legal U.S. residents of MA, RI, CT, NH, VT, and ME who are 18 years of age or older as of Friday, December 12, 2025. Employees, officers, directors, managers and members, along with their respective immediate family members, of Sponsor and Delaware North Companies, Inc- Boston (“DNCB”) its affiliates, and any other entities involved in any manner with the marketing, sponsoring, fulfilling or administration of the Sweepstakes (collectively, the “Sweepstakes Entities”), are not eligible to participate or win. The term “immediate family member” includes spouses, parents, step-parents, children, step-children, siblings, step-siblings, grandchildren, step-grandchildren or other family extension, regardless of where they live, and any persons residing in the same residence as the winner at least (3) months per year, whether related or not.

All comments must tag another valid Instagram account to be counted as a valid Entry. Normal Internet access, phone charges and usage charges imposed by your online/ phone service provider will apply. All Entrants must be following @bostonproshop, @1987thelabel, and @tdgarden until at least the end of the Sweepstakes Period. If selected as a winner, @bostonproshop will direct message participants to ask Entrants their name, age, phone number, email address, and shipping address.

Sponsor reserves the right to reject any Entry that it deems, in its sole discretion; to violate any of these content related requirements. By submitting an Entry (or accepting any prize), each Entrant understands and agrees that their Entry, including individual name may be posted online and further exploited by Sponsor for promotional purposes, without further compensation or review, and will not be returned. Each Entrant represents that the Entry is true and correct, and that he or she is authorized to submit such entry. Sponsor reserves the right to crop or reformat any entry in whole or in part, to be viewable online.

Limit of one entry per person during the Entry Period. Multiple Entries as determined by Sponsor in its sole discretion, will result in disqualification of all Entries by such person. 5. **Determination of Winner:** At the conclusion of the Sweepstakes Period, two (2) winners will be selected. Winners will be selected from all eligible Entries. The winners will be notified via email if winning Entry was submitted via Alternate Means of Entry or via Direct Message if winning Entry was made via Instagram on Tuesday, December 23, 2025. The Sponsor's decisions are final, binding and conclusive on all matters related to the Sweepstakes. If the winner is not responsive within twenty-four (24) hours of initial notification or in the event of non-compliance with any of these requirements, the prize will be forfeited, and an alternative winner will be chosen. Up to two alternative winners will be selected.
  
6. **Prizes:** Two (2) prizes will be awarded at the conclusion of the Sweepstakes Period. The prizes will consist of a Bruins prize pack, with four Bruins x 1987 products, and a Celtics prize pack, with four Celtics x 1987 products. In the event the game is cancelled or postponed for any reason, Sponsor reserves the right to substitute or award an alternative prize of approximate value with no further obligation to the winner. The estimated value of each prize is \$600. The prizes cannot be exchanged for cash and there are no date or seat substitutions. Transfer of any prize is prohibited unless approved by Sponsor. All taxes and all other expenses, costs or fees, including parking and transportation, associated with the acceptance and/or use of a prize are the sole responsibility of the winner. The winner must present valid government-issued identification. Sponsor may require additional verification of identity. Sponsor reserves the right to substitute a similar prize of equal or greater value at its sole discretion.
