

## 2026 BRUINS APP SWEEPSTAKES

### OFFICIAL SWEEPSTAKES RULES

---

- **NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT IMPROVE YOUR ODDS OF WINNING.**
- **VOID WHERE PROHIBITED. ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS APPLY.**
- **BY ENTERING THIS SWEEPSTAKES, THE ENTRANT AGREES TO THESE OFFICIAL SWEEPSTAKES RULES AS A BINDING CONTRACT.**

**Sponsor and Administrator:** 2026 Bruins App Sweepstakes (“Sweepstakes”) is sponsored and administered by Boston Professional Hockey Association, Inc. (“Sponsor”).

**General:** By participating in this Sweepstakes, the participant acknowledges and agrees to all of these Official Rules. Void where prohibited. Sweepstakes begins on Friday, April 3, 2026, at 10:00 AM, and runs until Saturday, April 11, 2026, at 5:00 PM (collectively the “Sweepstakes Period”). The odds of winning the prize depend on total number of eligible entries received during the Sweepstakes Period (each an “Entry”). Sponsor cannot accurately predict the number of entrants who will participate in the Sweepstakes (each an “Entrant”). All times in this Sweepstakes refer to Eastern Time. By participating, Entrants agree to be bound by these Official Rules and by all decisions of the Sponsor, whose decisions are at its sole discretion and are binding and final. Failure to comply with these rules will result in disqualification from this Sweepstakes.

**Eligibility:** The Sweepstakes is open only to legal U.S. residents of MA, CT, NH, VT, and ME who are 18 years of age or older as of Friday, April 3, 2026. Employees, officers, directors, managers and members, along with their respective immediate family members, of Sponsor and Delaware North Companies, Inc- Boston (“DNCB”) its affiliates, and any other entities involved in any manner with the marketing, sponsoring, fulfilling or administration of the Sweepstakes (collectively, the “Sweepstakes Entities”), are not eligible to participate or win. Bruins/TD Garden app on your mobile device in the app store. Click on the first slider graphic in the app's carousel, with the headline, "Enter to Win 2 Bruins Tickets, \$100 ProShop Gift Card, and \$100 Banners Gift Card". Follow the link and complete the Sweepstakes Entry form, found at [https://tradablebits.com/tb\\_app/544284](https://tradablebits.com/tb_app/544284). Normal Internet access, phone charges and usage charges imposed by your online/ phone service provider will apply. Entrants must include their name, DOB, phone number, email address, zip code, and state of residence.

Sponsor reserves the right to reject any Entry that it deems, in its sole discretion; to violate any of these content related requirements. By submitting an Entry (or accepting any prize), each Entrant understands and agrees that their Entry, including individual name may be posted online and further exploited by Sponsor for promotional purposes, without further compensation or review, and will not be returned. Each Entrant represents that the Entry is true and correct, and that he or she is authorized to submit such entry. Sponsor reserves the right to crop or reformat any entry in whole or in part, to be viewable online.

**You may be asked to consent to receive promotional emails or offers. This is optional and does not affect your chances of winning a prize in this Sweepstakes. You are NOT required to give consent to receive such emails or offers in order to participate in the Sweepstakes or win any prize. You may opt out of this service at any time by clicking 'unsubscribe' within the email.**

Limit of one entry per person during the Entry Period. Multiple Entries as determined by Sponsor in its sole discretion, will result in disqualification of all Entries by such person. Entries that do not conform to or that violate these Official Rules or are submitted in any manner other than stated in these Official Rules will be disqualified. By entering this Sweepstakes, Entrants agree to these Official Rules and the decisions of the Sponsor, which are binding and final in all matters relating to this Sweepstakes.

**Determination of Winner:** At the conclusion of the Sweepstakes Period, one (1) winner will be selected. Winner will be selected from all eligible Entries. The winner will be notified via phone and/or email on Saturday, April 11, 2026 at 5:00 PM. The Sponsor's decisions are final, binding and conclusive on all matters related to the Sweepstakes. If the winner is not responsive within twenty-four (24) hours of initial notification or in the event of non-compliance with any of these requirements, the prize will be forfeited, and an alternative winner will be chosen. Up to two alternative winners will be selected.

**Prizes:** One (1) prize will be awarded at the conclusion of the Sweepstakes Period. The prize consists of two (2) tickets to the Boston Bruins vs. New Jersey Devils game on April 14, 2026, a \$100 Banners Kitchen & Tap gift card, and a \$100 Boston ProShop gift card. The Sponsor reserves the right to substitute or award an alternative prize of approximate value with no further obligation to the winner. The estimated value of the prize is \$570. The prizes cannot be exchanged for cash and there are no date or seat substitutions. Transfer of any prize is prohibited unless approved by Sponsor.
